3. Have a net income of \$22,637 or less for a single person and \$28,182 or less for those who are married or common-law. (Please include copy of your **2010 Income Tax Notice of Assessment**).
4. Be in good academic standing (if you are a returning student) with a minimum 2.00 CGPA.
5. Complete and submit this application to any Registrar and Information Services counter (Burnaby, Surrey, or Vancouver) for Summer 2012 term by April 20, 2012.
